### Objectives of FSSA




- To consolidate the laws relating to food

### Recent Advisory

#### STATUTORY ADVISORY

Subject: - Extending time period for seeking conversion/ renewal of existing licenses/ registrations granted under the repealed Orders by FBO

As per the provisions given under Clause 2.1.2 of Licensing/Registration of Food Businesses Regulation, 2011, the food business operator has to apply for conversion / renewal of registration/ license within one year from the date of notification. This time period was to expire on 4<sup>th</sup> August, 2012. The approval of the Competent Authority is hereby conveyed for extending the time period granted to food business operators for seeking conversion/ renewal of licenses by another six months with effect from 5<sup>th</sup> August, 2012.

What we must do

 Obtain a valid license from Central/State licensing authority for all the manufacturing facilities and warehouses/distributors

Product approval as required.

Product safety study by independent institute if required.

Convert the existing PFA/FPO/VOP licenses to FSSA license under by 5<sup>th</sup> July 2012

 Ensure compliance with all the conditions of license & Schedule 4 requirements at all times

File the nominations with the Licensing Authorities in Form IX for all units/branches

- Technical person needed as a supervisor in production
- Testing of contaminants in to be done once in six months
- Compliance to Schedule 4
- Testing of water once in a year for Potability.
- Business to be performed with only licensed/registered vendors

License number to be printed on the pack.

• File returns in Form "D1" every year before 31st of May and separate returns for every license to be filed.

FSMS Plan or Certificate

Monitoring/Surveillance/Improvement notices

Product recall/traceability procedure compulsory

#### Liability for Compliance (section 27)

✓ Manufacturer shall be liable for meeting all requirements under this Act

#### Wholesaler/distributor shall be liable only for

- Sale after expiry
- stored or supplied in violation of the safety instruction
- Unsafe or misbranded
- Manufacturer unidentifiable
- Received with knowledge of being unsafe
- ✓ Seller shall be liable only for
- Sale after expiry
- Handled or kept in unhygienic conditions
- Misbranded
- Manufacturer unidentifiable





### **New Product Cell**

- FSSAI Has established the 'New Product Approval Cell"
  - FSSAI has made compulsory to get additives and
     New Product approval including proprietary foods.
  - Without Product approval or NOC for new products the license will be not issued.
  - Before 5<sup>th</sup> August 2012 every food business operator should apply for license.

#### **Present Status**

- India has more than 10,000 food products in Trade
- ➤ The Food Safety & Standards Regulation 2011 have given quality/safety specifications for nearly 320 food products.
- Rest all Products comes under category of Proprietary food.
- Section 22 has described the product for Neutraceutical/Novel Foods and Organic Foods etc


### What is Proprietary Food?

#### As per Regulation 2.12.1

Proprietary food means a food that has not been standardized under these regulations In addition to the provisions including labeling requirements specified under these regulations, the proprietary foods shall also conform to the following requirements, namely:—

- (i) the name describing as clearly as possible, the nature or composition of food and/or category of the food under which it falls in these regulations shall be mentioned on the label
- (ii) the proprietary food product shall comply with all other regulatory provisions specified in these regulations and in Appendices A and B.



### **New Advisory**

- All novel/first time use ingredient/food need approval
- Apply in prescribed form along with safety data and copy of label
- If product is as per 'Indian Food Code' separate product approval is not required.
- If product is approved for other company- same formulation need not to apply for product approval
- PI see the list of NOCs issued so far
- NOC will be issued for the product which are using new additive (first time in India)
- Existing license holder will continue to do the business and apply for advisory as required
- Novel product will go for scientific Panel-No NOC will be issued.
